#### Tax Installment Payment Plan - TIPP

The Tax Installment Payment Plan (TIPP) allows residents to sign up for a monthly, direct withdrawal of their property tax payments from their bank accounts.

This plan provides taxpayers the opportunity to pay their property taxes in monthly installments rather than the one large single payment that comes due once per year. The plan runs from January 1 - December 31, yearly. For the 2024 taxation year, your application must be received no later than March 15, 2024, provided that a pro-rated portion of your taxes are paid in advance.

If you have an outstanding balance on your 2023 Property Taxes (from transferred utilities or bylaw enforcement costs), your TIPP program may be suspended until the outstanding balance has been paid in full. Please call the Town Office at 780-895-2010 to make payment arrangements.


#### **Dog Licenses**

## **Utility Billing Increase**

Effective January 1, 2024 there will be a 1.5% increase to water/sewer charges, a 3% increase on garbage collection rates, and a 0.5% increase to the cost recovery and capital investment fees. You will see these increases on your March invoice.

<b>Bi-Monthly Billing Charge</b> (Residential & Commercial)	2023	2024	Increase
Resident consumed 3,000 gallons (13.6m3) in 2 months	\$163.00	\$166.24	\$3.24
Resident consumed 5,000 gallons (22.7m3) in 2 months	\$207.57	\$211.48	\$3.91
Resident consumed 12,000 gallons (54.48m3) in 2 months	\$363.54	\$369.82	\$6.28



#### **Snow Removal**

As per Bylaw 10/23, Community Standards, the owner or occupant of any property adjacent to a sidewalk is responsible for the removal of all snow and ice from that portion of the sidewalk within **seventy two (72) hours** of a snowfall. Snow removed from driveways, parking lots, service lots or sidewalks shall NOT be placed or moved onto highways/streets, sidewalks or private property.

The Town will be monitoring sidewalks after snowfalls. Residents who do not clear the snow from adjacent sidewalks will be fined.
