Kim was my neighbour my entire 18 years of living in Lamont. Kim was also an Educational Assistant, and a librarian for a short time at Lamont Elementary School. Kim passed away February 18, 2015, I remember a time where Kim had mentioned starting up something about a bike park in town, something for the kids to do. Her 2 sons were always riding bikes, building ramps, and doing tricks on their bikes. All of us kids in the neighbourhood rode bikes all together, just never had a designated spot in town to do so.

I was overwhelmed with the amount of support I got in the first 4 days. I reached over 50 signatures In the first 4 days. Now today, 2 weeks later I have made it into an article in the Lamont Leader, and I am currently standing at 124 signatures. I feel deeply in my heart this is something our community would really love and appreciate. I feel this would be very fitting for Kim and her family.

I have attached a list of names of the people who signed, and commented on my petition. I have also attached a few messages from people, one being her son that I have received regarding how they feel towards this request.

Again, I thank you very much for your time and consideration. I can't wait to hear back from you soon.



#### RE: Eastern Slopes Coal Exploration & Public Consultation on the 1976 Coal Development Policy

Dear Your Worship & Members of Council:

The Province has initiated the public consultation process for all Albertans to provide their voice as it relates to Coal Development on the Eastern Slopes of the Rockies. However, this iconic landscape remains threatened due to continued exploration activities.

The Town of High River is requesting your support to encourage the Province and the Alberta Energy Regulator to cease all exploration on Category 2 lands within the Eastern Slopes of the Rockies. In addition, we want to encourage all municipalities to actively participate in the public consultation process to ensure our opinions and the voices of our residents are heard. Protection of this valuable landscape and the watersheds that will be impacted by any coal development activity is important to every resident of Alberta.

At the April 12, 2021 Regular Meeting of Council, the following resolution was adopted:

**BE IT RESOLVED THAT** Council direct Administration to draft a letter to be signed by the Mayor and sent to Premier Jason Kenney and Minister Sonya Savage requesting that the Alberta Energy Regulator stop all activities associated with Coal Exploration Permits on the Category 2 lands that were approved prior to February 8, 2021;

**AND THAT** given that public consultation that has begun regarding coal mining on the Eastern Slopes, Council requests that these coal exploration projects be put on hold by the Alberta Government until final decisions have been made regarding the extraction of coal on the Eastern Slopes of Alberta or the elimination of the extraction of coal, especially given the destruction that exploration causes and the effects on our landscapes and our watersheds;

**AND THAT** Council direct Administration to draft a letter to be signed by the Mayor and sent to all municipalities in Alberta encouraging them to also send letters to Premier

Kenney and Minister Savage supporting the stoppage of exploration activities on the Eastern Slopes.

**AND FURTHER THAT** the Town of High River also encourages all municipalities to participate fully in the ongoing Public Consultation Process, including Phase 1, which is the gathering of information that the committee will use to draft the actual Public Consultation process.

The Town has sent letters to Premier Kenney and Minister Savage requesting that the Alberta Energy Regulator stop all activities associated with Coal Exploration Permits on the Category 2 lands that were approved prior to February 8, 2021. In addition, these letters request that the coal exploration projects be put on hold until final decisions have been made about the extraction or the elimination of extraction of coal from the Eastern Slopes, following a meaningful public consultation process.

The Town of High River is respectfully requesting your continued support and that you consider writing to Premier Kenney and Minister Savage requesting that all exploration activities on the Eastern Slopes of the Rockies be ceased, pending the outcome of a meaningful public consultation process. Re: Town of Morinville Support for RCMP

Our Council is not supportive of the Government of Alberta's initiative to replace the RCMP with an Alberta Provincial Police Service (APPS). Our opinion is that there are other, more effective ways to achieve the outcomes identified through the *Police Act* review. Indeed, improving the public's trust in policing, ensuring an effective complaint process, and improving Indigenous peoples' relationships are important objectives.

There are, however, several considerations that cause justifiable concern:

- The Fair Deal Panel recommends establishing an APPS despite 65% of respondents indicating non-support;
- The necessity for a new model is unclear when there is little substantiated dissatisfaction with the RCMP but rather some areas for improvement have, rightfully, been identified;
- Transition costs are poorly understood, and ongoing operating costs will inevitably rise. Municipalities currently bear the majority of policing costs and are not able or willing to accept any additional increases. As you know, municipalities have limited means to increase revenues, receiving only 8-10 cents for every tax dollar collected. Continuing to do more with less is untenable.

There has not been compelling evidence that an APPS would result in better outcomes, particularly with the expected increase in costs. The Town of Morinville has a collaborative relationship with the local RCMP detachment and is satisfied with the level of service and degree of responsiveness received. As such, Council encourages the Government of Alberta to abandon the transition study and redouble efforts to work with the RCMP to achieve better outcomes.

Our Council wishes to advise they are also not in support of the Government of Alberta's initiative to replace the RCMP with an Alberta Provincial Police Service (APPS) as affirmed in Mayor Turner's letter from the Town of Morinville.

Council agrees that by revising the *Police Act*, the outcomes as identified through the review can be achieved such as improving the public's trust in policing, ensuring an effective complaint process, and having a more harmonious relationship between the police and all communities within Alberta.

Council too has concerns with the province establishing an APPS despite 65% of respondents indicating non-support. The costs of transitioning to an APPS are unknown and the increased operating costs will undoubtedly be borne by the municipalities. The municipalities are currently bearing a substantial amount of policing costs and are not willing to accept unknown additional increases that will be inevitable from a transition to an APPS. This simply cannot be done within a short time frame to offer the expertise and services currently provided to Albertans by the RCMP.

Our County has developed a collaborative relationship with our local RCMP detachment over many years and is satisfied with the level of service and degree of responsiveness received and their involvement with the communities located in the County. Council echoes and encourages the Government of Alberta to abandon the transition study and redouble efforts to work with the RCMP to achieve better outcomes.

## Land and Property Rights Tribunal - Fact Sheet

Legislative Amalgamation of the Land Compensation Board (LCB), Municipal Government Board (MGB), New Home Buyer Protection Board (NHBPB) & Surface Rights Board (SRB)

### Background

The LCB, MGB, NHBPB, and SRB are independent, quasi-judicial tribunals that make decisions about land planning, property assessment and compensation disputes involving land expropriations and surface leases.

These boards were administratively amalgamated in 2017 as part of a government-wide review of all Agencies, Boards and Commissions. This involved having a common Chair to oversee all four boards, sharing administrative staff and a common location. These changes generated annual cost savings of approximately \$500,000.

## What is changing?

The LCB, MGB, NHBPB and SRB will be amalgamated into the **Land and Property Rights Tribunal (LPRT)** pursuant to the *Land and Property Rights Tribunal Act*. This legislation was introduced under *Bill 48*, the *Red Tape Reduction Implementation Act, 2020*. Bill 48 received royal assent on December 09, 2020.

This will consolidate the jurisdiction and administration of these boards into one entity, the LPRT.

# When will the amalgamation take effect?

The LPRT will come into existence on **June 02**, **2021**, replacing the LCB, MGB, NHBPB, and SRB.

## Why are these boards being amalgamated?

The LPRT is being created as part of the next phase of the administrative amalgamation to further streamline services, improve efficiency and reduce costs.

## Key Highlights

Board members of the LCB, MGB, NHBPB and SRB will become members of the LPRT.

The LPRT will have common rules of procedure and Mandate and Roles to simplify and streamline processes for parties.

Having a larger pool of board members to assign to proceedings improves the flexibility to respond to shifting workloads and the tribunal's ability to retain the best and most experienced members.

This change will not affect rights of parties or existing applications or appeals so anyone who has already submitted materials won't have to take any additional steps.

Contact information for the LPRT has not changed. The LPRT will retain email addresses and phone numbers of the LCB, MGB, NHPBP, and SRB until further notice.

#### RECOMMENDATION

- 1. That Council give first reading to Bylaw 04/21, Municipal Property Tax Rebate Program.

#### BACKGROUND

Economic development has been established as a key priority for the Town, both from the public's perspective as well as through Council's Strategic Plan. As such, Administration has continued to work to identify ways to boost development within the community to help to create more opportunity in this priority area.

It is proposed at this time to create a Municipal Property Tax Rebate Program. The key component of this proposed program is to provide a reduction to the municipal taxes for a period of three years for lands that are developed and meets the conditions of the program. In principle, by including an incentive program to reduce the costs for new development, there is potential opportunity to attract development to the community. It is important to note that this rebate program only applies to the municipal portion of taxes and that all other requisitions and land tax would continue to be due and payable each year.

#### COMMUNICATIONS

- The program will be advertised on social media and on the Town's website.
- Information will be shared to business community through the Lamont & District Chamber of Commerce and other methods of advertising such as the local newspaper.



### IMPLICATIONS OF DECISION

The proposed program is set out as follows:

#### *Eligible applications would need to meet the following criteria:*

- New Residential Construction with approved development and building permits dated after this Bylaw comes into effect.
- New Construction\* with approved development and building permits dated after this Bylaw comes into effect.
- Existing homes that are demolished to accommodate construction of a new residence.
- Existing commercial or industrial buildings that are demolished to accommodate new construction.
- Applicant must be the legal landowner, as named on the certificate of title.

### Additional requirements:

- Rebate is restricted to one (1) New Construction or one (1) New Residential Construction per lot.
- New Construction or New Residential Construction applies to permanent structures situated on a permanent foundation and complies with the Alberta Building Code.
- Municipal Property Taxes must be paid by the due date indicated on the Tax notice during the eligible Rebate Period, or eligibility will be terminated.
- Applications must be received by the Town of Lamont by December 1st each year during the Rebate Period to be eligible.
- All New Construction or New Residential Construction must conform to the Town of Lamont Land Use Bylaw and Alberta Building Code regulations.
- The property taxes must be current at the time of the application or the application for rebate will be cancelled.

## \*New Construction means new commercial or industrial structures constructed on vacant lands or replacing removed or demolished existing structures as defined in the Town of Lamont Land Use Bylaw.

In addition, a request was recently received that outlines how an incentive program for tax rebates would be beneficial to increase residential development in the community. Details have been attached for reference. If Council moved forward with approving the bylaw to allow for the program to commence, Administration would proceed with the rollout of the program and work with the request that has been received.

Similar municipal tax rebate programs are currently being offered in other municipalities including in our region, such as Redwater and Bruderheim.



The draft bylaw was recently circulated to the business community through the Lamont & District Chamber of Commerce for external input. At the time of the report, the following input was received:

- I have read a copy of the proposed Bylaw re Municipal Tax Rebate Bylaw and its relation to the building of new residential and commercial projects in the Town of Lamont.
- In my opinion it is clear and defines the Bylaw in plain language.
- I have discussed your proposed Bylaw with other parties involved in the construction trade and the comments in regards to the incentive details of the Bylaw were all positive.

Council may wish to receive the report as information to allow additional time for feedback to be provided.

### FINANCIAL IMPLICATIONS

The financial implications would vary depending on the participation in the program.

In general terms, the rebate offered is related to the municipal property tax that the Town would not collect for 3 years. The eligible applicants would be responsible for all other requisitions along with the land tax.

Below is an example demonstrating how the rebate is applied assuming the assessed value is consistent, and the improvement value is driven from the stage of completion. The current year is the year of application and the start of construction.

The total rebate possible for the application would be \$7,739.78.

## BEING A BYLAW OF THE TOWN OF LAMONT IN THE PROVINCE OF ALBERTA, TO PROVIDE FOR A MUNICIPAL PROPERTY TAX REBATE PROGRAM

**WHEREAS** the Council of the Town of Lamont deems it necessary to provide for a Municipal Property Tax Rebate Program.

**NOW THEREFORE** pursuant to the provisions of the *Municipal Government Act*, R.S.A. 2000 c.M-26 and amendments thereto, the Council of the Town of Lamont, hereby enacts as follows:

## 1. BYLAW TITLE

a. This Bylaw is known as "Municipal Tax Rebate Bylaw".

## 2. DEFINITIONS

For the purposes of this Bylaw:

- a. "Act" means the *Municipal Government Act*" RSA 2000, c.M-26;
- b. "Bylaw" means this Municipal Property Tax Rebate bylaw established by the Municipality;
- c. "Construction Start Date" means the date the Building Permit is issued;
- d. "Council" means the Council for the Town of Lamont;
- e. "Municipality" means the Town of Lamont;
- f. "Municipal Property Tax" means those taxes collected on the Town of Lamont tax notice excluding Requisitions;
- g. "New Construction" means new commercial or industrial structures constructed on vacant lands or replacing removed or demolished existing structures as defined in the Town of Lamont Land Use Bylaw;
- h. "New Residential Construction" means new residential structures constructed on vacant lands or replacing removed or demolished existing structures, including new modular homes, as defined in the Town of Lamont Land Use Bylaw;
- i. "Principal Building" means a building that is the Principal building of occupation and excludes accessory buildings;
- j. "Rebate Period" is either:
  - a. a three year term beginning January 1 following the Construction Start Date for New Construction, or
  - b. a three year term beginning January 1 following the Construction Start Date for New Residential Construction.
- k. "Requisitions" means a school and seniors requisitions collected on the Town of Lamont Tax notice.

## 3. APPLICATION PROCEDURES FOR DETERMINATION OF ELIGIBILITY

- a. Eligible New Construction and New Residential Construction is for the Principal Building structure only.
- b. Eligible applications must meet the following criteria:
  - i. New Residential Construction with approved development and building permits dated after this Bylaw comes into effect.
  - ii. New Construction with approved development and building permits dated after this Bylaw comes into effect.
  - iii. Existing homes that are demolished to accommodate construction of a new residence.
  - iv. Existing commercial or industrial buildings that are demolished to accommodate new construction.
  - v. Applicant must be the legal landowner, as named on the certificate of title.
- c. Rebate is restricted to one (1) New Construction or one (1) New Residential Construction per lot.
- d. New Construction or New Residential Construction applies to permanent structures situated on a permanent foundation and complies with the Alberta Building Code.
- e. Municipal Property Taxes must be paid by the due date indicated on the Tax notice during the eligible Rebate Period, or eligibility will be terminated.
- f. Applications for Rebate must be completed annually during the Rebate Period in a form prescribed by the Town of Lamont.
- g. Applications must be received by the Town of Lamont by December 1st each year during the Rebate Period to be eligible.
- h. All New Construction or New Residential Construction must conform to the Town of Lamont Land Use Bylaw and Alberta Building Code regulations.
- i. The property taxes must be current at the time of the application or the application for rebate will be cancelled.
- j. Requisitions are not eligible for a rebate and must be paid by the applicant.
- k. The Municipal Property Tax Rebate applies only to the municipal portion of taxes and does not apply to taxes on the land assessment or the requisitions such as the Alberta Education requisition and Lamont County Seniors Foundation requisition.

## 4. PROVISIONS AND REGULATIONS

a. Council may make rules and regulations consistent with this Bylaw for the effectual carrying out of this bylaw and for the efficient management, control and regulation of the bylaw.

## 5. SEVERABILITY

## TOWN OF LAMONT BYLAW 04/21

a. If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, the invalid portion shall be severed, and the remainder of the Bylaw is deemed valid.

## 6. EFFECTIVE DATE

a. That this Bylaw shall come into force and take effect upon the date of third reading and is duly signed.

- 2. The homes would be in the 1200 sq ft to 1500 sq ft size
- 3. Because of the real estate economics in Lamont which is presently a Buyers Market we are looking at the feasibility of building on these vacant lots at a pace of one at a time.
- 4. The present tax base of each of these lots is approximately \$570 each.
- 5. With our proposed new home builds the municipal tax base for each of the lots should generate approximately \$1800 increase in revenue per lot per subsequent years (30 plus years).
- 6. I have also attached the Municipal Property Tax Rebate document that outlines the incentive provided by the neighboring Town of Bruderheim(as an example only) The incentive to build that is being requested from the Town of Lamont is a Property Tax Rebate Period of three years with the term beginning January 1 following the Construction Date for new residential construction pertaining to the lots 75 and 76 and 79 Block 11 Plan 0823278.

#### **BYLAW 16-2018**

## MUNICIPAL PROPERTY TAX REBATE BYLAW

## A BYLAW OF THE TOWN OF BRUDERHEIM, IN THE PROVINCE OF ALBERTA, TO PROVIDE FOR A MUNICIPAL PROPERTY TAX REBATE PROGRAM

WHEREAS The Council of the Town of Bruderheim deems to provide for a Municipal Property Tax Rebate Program;

**NOW THEREFORE,** pursuant to the provisions of the Municipal Government Act, Chapter M-26.1, 2000 and amendments thereto, the Council of The Town of Bruderheim in the Province of Alberta, duly assembled, does hereby enact as follows:

#### PURPOSE

Provide opportunities to build new homes, commercial businesses, and industrial facilities without having to make Municipal Property Tax payments on the improvements to the land for three years.

### 1.0 Definitions

- 1.1 **"Bylaw"** means this Municipal Property Tax Rebate bylaw established by the Municipality;
- 1.2 **"Construction Start Date"** means the date the first placement of permanent construction of a structure on a site, such as the pouring of a slab or footings, the installation of piles, the construction of columns, or any work beyond the stage of excavation;
- 1.3 "Council" means the Council for the Town of Bruderheim;
- 1.4 "Municipality" means the Town of Bruderheim;
- 1.5 **"Municipal Property Tax"** means those taxes collected on the Town of Bruderheim tax notice excluding Requisitions;
- 1.6 **"New Construction"** means new commercial or industrial structures constructed on vacant lands or replacing removed or demolished existing structures as defined in the Town of Bruderheim Land Use Bylaw;
- 1.7 **"New Residential Construction"** means new residential structures constructed on vacant lands or replacing removed or demolished existing structures, including new manufactured homes, as defined in the Town of Bruderheim Land Use Bylaw;

- 1.8 **"Primary Building"** means a building that is the primary building of occupation and excludes accessory buildings;
- 1.9 **"Rebate Period"** is either:
  - 1.9.1 a three year term beginning January 1 following the Construction Start Date for New Construction, or
  - 1.9.2 a three year term beginning January 1 following the Construction Start Date for New Residential Construction; or
  - 1.9.3 a three year term beginning January 1 following the Construction Start with additions to buildings, where the increase in assessment is equal to at least 50% of the original assessment;
- 1.10 **"Requisitions"** means school and seniors requisitions collected on the Town of Bruderheim Tax notice.

## 2.0 Application procedures for determination of eligibility

- 2.1 Eligible New Construction and New Residential Construction is for the Primary Building only.
- 2.2 Eligible applications are:
  - 2.2.1 New Residential Construction with approved development and building permits dated after this Bylaw comes into effect;
  - 2.2.2 New Construction with approved development and building permits dated after this Bylaw comes into effect.
  - 2.2.3 Existing homes that are demolished to accommodate the construction of a new residence. The taxes for the period of the year following the date of removal will be abated for the then current year and Municipal Property Tax Rebate will apply as per the rebate period requirements.
  - 2.2.4 Existing commercial or industrial buildings that are demolished to accommodate a new construction. The taxes for the period of the year following the date of removal will be abated for the then current year and the Municipal Property Tax Rebate will apply as per the rebate period requirements.
  - 2.2.5 Additions to residential and non-residential construction for a three year term beginning January 1 following the Construction Start, where the increase in assessment is equal to at least 50% of the original assessment;
- 2.3 Applicant must be the legal landowner, as named on the certificate of title.
- 2.4 Rebate is restricted to one New Construction or one New Residential Construction per lot.
- 2.5 New Construction or New Residential Construction applies to permanent structures situated on a basement or concrete foundation.



- 2.6 In all cases, the land on which the New Construction or New Residential Construction is situated will not be eligible for the Municipal Property Tax Rebate.
- 2.7 Municipal Property Taxes must be paid by the due date indicated on the Tax notice during the eligible Rebate Period, or eligibility will be terminated.
- 2.8 Applications for Rebate must be completed annually during the Rebate Period in the form on Schedule A.
- 2.9 Applications must be received by the Town of Bruderheim by December 1st each year during the Rebate Period to be eligible.
- 2.10 All New Construction or New Residential Construction must conform to the Town of Bruderheim Land Use Bylaws and Alberta Building Code regulations.
- 2.11 The property taxes must be current at the time of the application or the application for rebate will be disqualified.
- 2.12 Requisitions are not eligible for a rebate and must be paid by the applicant.
- 2.13 The properties listed in Schedule B will continue on the Tax Free for Three Policy Policy until their three year application expires.
- 2.14 The Municipal Property Tax Rebate does not include taxes on the land.

#### 3.0 Provisions and Regulations

3.1 Council may make rules and regulations consistent with this Bylaw for the effectual carrying out of this bylaw and for the efficient management, control and regulation of the bylaw.

#### 4.0 Severability

4.1 It is the intention of the Town Council that each separate provision of this bylaw shall be deemed independent of all other provisions, and it is further the intention of Town Council that if any provision of this Bylaw be declared invalid, that the provision shall be deemed to be severed and all other provisions of the Bylaw shall remain in force and effect.

#### 5.0 General

- 5.1 This Bylaw shall come into force on the Third and Final reading.
- 5.2 Upon Third and Final Reading of Bylaw 16-2018, this Bylaw rescinds Bylaw 05-2018.

## RECOMMENDATION

- 1. That Council authorize a transfer of \$148,955 from operations to Planning and Subdivision Reserve for capital projects as approved within the 2021 Operating Budget.
- 2. That Council authorize the transfer of a maximum of \$25,000 from Administration Reserve to operations for CAO Recruitment.
- 3. That Council authorize the transfer of \$62,000 from General Reserve to operations for water infrastructure repair and maintenance for emergency watermain repair.

#### BACKGROUND

The 2021 Operating Budget and Mill Rates were approved by Council during the April 13, 2021 Council meeting. Included within the budget was a reserve transfer of \$148,955 from operations to the Planning and Subdivision reserve for current and/or future years' capital project(s).

Further, the CAO Recruitment cost was not confirmed at the time the budget was passed. Therefore, a reserve transfer is recommended for this item. The costs for recruitment could be transferred from Administration reserve. The current balance of this reserve account is \$486,127.12.

Public Works has recently had significant emergency repairs required with the water infrastructure. The final costs for the emergency watermain break that occurred in February have just been received, resulting in an expense in the amount of \$61,055.67. This cost combined with other emergency repairs required to the 54<sup>th</sup> Street Reservoir, that were identified during an annual inspection this week, were also not anticipated. Both of which will cause an overage in the water infrastructure repair and maintenance budget. Transferring the cost of the watermain break from general reserves will leave funds available for regular repair and maintenance of our water infrastructure for the balance of 2021. The current balance in the General Reserve account is \$384,128.86.
